RESOLUTION NO. 67 (2019)

WHEREAS, there is a need to amend the FY20 Civil Law budget to add one new position
“Family Safety Attorney”; and,

THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians at which a quorum
is present that the Civil Law budget amendment is hereby approved as follows:

1. Changes to “Tribal” as follows:
 - a. Increase to “Regular Pay” expense \$95,847;
 - i. Addition of “Family Safety Attorney” Position #906517033 at 46.08 per hour \$95,847;
 - b. Increase to “Retirement” expense \$4,793;
 - c. Increase to “SUTA” expense \$240;
 - d. Increase to “FICA” expense \$5,943;
 - e. Increase to “Medicare” expense \$1,390;
 - f. Increase to “Workman’s Comp” expense \$2,013;
 - g. Increase to “Health Insurance” expense \$7,312;
 - h. Increase to “Dental/Vision” expense \$323;
 - i. Increase to “Group Life” expense \$869;
 - j. Increase to “Indirect Cost” expense \$27,796;
 - k. Increase to “Operating Transfers in Tribal” revenue \$(146,526);

BE IT FINALLY RESOLVED that this resolution shall become effective upon ratification by
the Principal Chief and that the intent of this resolution be carried out by the Budget Office.




