RESOLUTION NO. 72 (2019)

WHEREAS, the youth worldwide want to make efforts to protect and conserve our world's natural resources; and

WHEREAS, we want to reduce the use of non-biodegradable plastics in our community; and

WHEREAS, the Tribe needs a law to encourage and will cause the use of biodegradable materials in commercial business and food industries on Tribal land.

NOW THEREFORE BE IT RESOLVED by Tribal Council of the Eastern Band of Cherokee Indians in Council assembled at which a quorum is present that Tribal Council direct the Attorney General's office to draft a proposed ordinance that will carry out the intentions of this resolution, and submit it to the January 2020 session of Tribal Council for a vote.

BE IT FURTHER RESOLVED that this resolution shall become effective upon ratification by the Principal Chief and \_\_\_\_\_ is authorized to carry out the intent of this resolution

BE IT FINALLY RESOLVED that all resolutions that are inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.


