RESOLUTION NO. 74 (2019)

WHEREAS, there is a lack of clean energy usage; and

WHEREAS, it is Cherokee culture to preserve and protect natural resources; and

WHEREAS, switching to clean energy, solar panels, for all Tribal buildings will help to ensure the preservation of our natural resources and save our Tribe money by cutting down on the cost of energy, while creating jobs to maintain the upkeep of the solar panels.

NOW THEREFORE BE IT RESOLVED by Tribal Council of the Eastern Band of Cherokee Indians in Council assembled at which a quorum is present that Tribal Council move forward towards clean energy through installing solar panels on all Tribal buildings.

BE IT FURTHER RESOLVED that a plan be created and implemented to install said solar panels on all Tribal buildings by December 31, 2020.

BE IT FINALLY RESOLVED that this resolution shall become effective upon ratification by the Principal Chief and _____ is authorized to carry out the intent of this resolution that all resolutions that are inconsistent with this resolution are rescinded, and that this resolution shall become effective when ratified by the Principal Chief.
