10 WHEREAS, Dorothy Lucille Lossiah Thompson, (Deceased January 24, 2017), enrolled
11 member of the Eastern Band of Cherokee Indians did not leave a Last Will and
12 Testament; and

14 WHEREAS, Sarah Nicole Thompson Toineeta has qualified as the Administratrix of the estate
15 of Dorothy Lossiah Thompson in Cherokee Court Estate File 17-020 and requests
16 that the deceased's legal heirs be recognized as the successors in interest to the
17 deceased's possessory holdings; and

19 WHEREAS, the Tribal Realty Office has examined the records on file regarding the deceased's
20 possessory holding in Tribal trust land, and other documents, and has written this
21 resolution to provide for the distribution of the deceased's possessory holding to
22 her eligible heirs.

24 NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council
25 Assembled, at which a quorum is present that the Tribal Council of the Eastern
26 Band of Cherokee Indians does hereby recognize the heirs of Dorothy Lossiah
27 Thompson: Albert Earl Martin, Jr. (enrolled) and Sarah Nicole Thompson
28 Toineeta (enrolled).

30 BE IT FURTHER RESOLVED that **Wolfetown Community Parcel No. 516 (Part of Parcel**
31 **No. 515)**, containing 1.062 acres, more or less, together with all improvements
32 located thereon, be assigned to Albert Earl Martin, Jr. (enrolled) and Sarah Nicole
33 Thompson Toineeta (enrolled).

35 BE IT FINALLY RESOLVED that the Tribal Business Committee and the Tribal Realty
36 Services are hereby authorized to carry out the intent of this resolution.




