WHEREAS, the Tribal Realty Office has examined the records on file regarding the deceased's possessory holding in Tribal trust land, and other documents, and has written this resolution to provide for the distribution of the deceased's possessory holding to her eligible heirs.

NOW, THEREFORE, BE IT RESOLVED by the Eastern Band of Cherokee Indians in Council Assembled, at which a quorum is present that the Tribal Council of the Eastern Band of Cherokee Indians does hereby recognize the heirs of Dorothy Lossiah Thompson: Albert Earl Martin, Jr. (enrolled) and Sarah Nicole Thompson Toineeta (enrolled).

BE IT FURTHER RESOLVED that Wolfetown Community Parcel No. 516 (Part of Parcel No. 515), containing 1.062 acres, more or less, together with all improvements located thereon, be assigned to Albert Earl Martin, Jr. (enrolled) and Sarah Nicole Thompson Toineeta (enrolled).

BE IT FINALLY RESOLVED that the Tribal Business Committee and the Tribal Realty Services are hereby authorized to carry out the intent of this resolution.
