RESOLUTION NO. 90 (2020)

WHEREAS, the Eastern Band of Cherokee Indians created the Tribal Employment Rights Commission ("Commission") as codified in the Cherokee Code §92-5(a); and

WHEREAS, the Commission shall have seven members, all of whom shall be enrolled members of the Eastern Band of Cherokee Indians per C.C §92-5(b); and

WHEREAS, the Tribal Council shall appoint two Commission members to serve a two-year term, C.C. §92-5(b)(2); and

WHEREAS, Commissioners may not serve more than two consecutive terms, C.C. §92-5(d)(1); and

WHEREAS, Mr. Johi Griffin served out the term of a previous Tribal Council appointment from March 1, 2017 through February 28, 2019; and

WHEREAS, the currently seated Tribal Employment Rights Commission, of which Mr. Griffin currently serves, received a national award recognizing it for the 2019 TERO Commission of the Year from the Council for Tribal Employment Rights; and

WHEREAS, through the collective leadership of the current Tribal Employment Rights Commission, Mr. Griffin's individual leadership and contribution is acknowledged and greatly appreciated.

NOW, THEREFORE BE IT RESOLVED, BY THE Tribal Council for the Eastern Band of Cherokee Indians in Council assembled, at which a quorum is present, the Tribal Council appoints and approves, \_\_\_\_\_, to the Tribal Employment Rights Commission.

BE IT FURTHER RESOLVED that \_\_\_\_\_ shall be appointed for a two-year term beginning on March 1, 2019 through February 28, 2021.

BE IT FURTHER RESOLVED that \_\_\_\_\_ is not an elected official, executive staff or program director per §92-5(c).

BE IT STILL FURTHER RESOLVED that \_\_\_\_\_ is an enrolled members of the Eastern Band of Cherokee Indians and has not served two consecutive terms per §92-5(b) and (d).

BE IT FINALLY RESOLVED that this resolution shall become effective upon ratification by the Principal Chief.


