35	WHEREAS,	the Farm Bill of 2018 and its associated federal regulations permit tribes to submit
36		hemp regulatory plans to the United States Department of Agriculture (USDA) in
37		order to become the primary regulator of hemp within their respective jurisdictions;

39 40	WHEREAS,	the Tribal Council also previously passed Resolution #24 (2020) which created the
41	willians,	Cannabis Commission and instructed the Commission, among other things, to
42		develop an EBCI Hemp Regulatory Plan for submission to the USDA so that the
43		Tribe may exercise its sovereignty by becoming the primary regulator of hemp on
44		Tribal lands; and
