RESOLUTION NO. 193 (2020)

WHEREAS.

Section 21 of the Charter and Governing Document of the Eastern Band of Cherokee Indians requires the Executive Committee to present a budget to the Tribal Council by July 1st of each year;

and

WHEREAS,

Section 117-47 of the Cherokee Code requires the Executive Committee to submit, and the Tribal

Council to adopt, only a balanced budget; and

WHEREAS.

upon receipt of the proposed annual budget the Budget Council will review and recommend

approval by the Tribal Council the annual operating budget for the Fiscal Year 2021, beginning

October 1, 2020, and running through September 30, 2021.

NOW THEREFORE BE IT RESOLVED by the Tribal Council of the Eastern Band of Cherokee Indians in Council

assembled, at which a quorum is present the Fiscal Year 2021 Budget of the Eastern Band of Cherokee Indians is approved for the period of October 1, 2020 through September 30, 2021.

BE IT FURTHER RESOLVED the Tribal Council does hereby approve the Organizational Charts presented with the

annual budget.

BE IT FINALLY RESOLVED the Principal Chief is authorized to expend funds based on this approved annual

operating budget for the Fiscal Year 2021 for the period of October 1, 2020, through September

30, 2021.
